AY 2022 SPRING SEMESTER CLASSES

Face-to-Face Learning Will Resume on Campus

In the AY 2022 spring semester, while prioritizing the health, safety, and lives of our students and staff members, APU has decided to hold classes in-person as a general rule if the BCP Level is at Level 2 or below in order to continue holding academic and extra-curricular activities in the multicultural environment that APU is best known for. However, as there are some students who have been unable to enter the country due to immigration restrictions, or who have underlying health conditions which make attending class in-person difficult, who may receive permission to attend some classes online. If you wish to attend class online, you must complete the necessary application procedures by the deadline and receive permission from the university to attend class online. Please keep this in mind when registering for AY 2022 spring semester classes. Please read below for details on class formats, preventative measures, and other important information.

1. OVERVIEW OF AY 2022 SPRING SEMESTER CLASSES

BASIC APPROACH TO CLASS IMPLEMENTATION

- In principle, courses will be held in person in a classroom. However, there are some students who cannot take classes in person because they have underlying conditions or cannot enter Japan. Such students will be allowed to take classes online on Zoom, excluding some courses. In addition, students who have permission to take classes online while unable to enter Japan can no longer take classes online if they are able to enter Japan mid semester. Please take classes in person after entering Japan.
- In principle, all language and lecture classes during the first week of Spring Semester (April 11 (Mon) 15 (Fri)) will only be held online to reduce the risk of a cluster outbreak resulting from students travelling from various regions, including large cities, and also because time is needed to assign classrooms appropriately once the number of students in each class is finalized. However, courses that the university has determined are 'classes that can only be taken in person' (classes that cannot be taken online) will be held in-person in a classroom.
- The maximum number of students allowed in each classroom will be calculated based on ensuring at least 1 meter of space between students, and will be used to set the size of each class. For this reason, in principle seats in in-person classes will be offered on a first come, first serve basis, and once capacity is reached more students will not be allowed to enter the classroom. If you are not allowed to enter the classroom, please go to an open classroom used for attending online classes and take the class from there. The class format starting from the next week of class will be announced by the course instructor.
- · After classes start, in-person classes may also be implemented online only depending on the COVID-19 situation and APU's BCP Level. Please make the necessary preparations to take classes online in advance. Students should check Campus Terminal and notices from the university regularly.
- The format of classes after Monday, April 18 will be announced in the week of March 7, so please regularly check Campus
 Terminal for announcements that week.

NOTES ON THE APPLICATION

- · Even if you receive permission to attend regular (in-person) classes online, if you become able to enter the country you will not be permitted to attend these classes online. After coming to Japan, please attend your classes in-person. (You will be able to continue attending classes online during the quarantine period after your arrival.)
- · If you have permission to enter the country but still wish to reside abroad and take classes online, please register for "online only" classes. The list of classes which will be offered online-only has not yet been confirmed. Please check yourself whether you will be able to earn the credits you need for graduation via online-only classes. The course timetable will be released on Tuesday, March 1.
- · Students who submit this application and wish to attend class by viewing recordings will have to submit a separate additional survey. See Section "5. Recorded Classes" for details

⑤ APPLICATION RESULTS

After confirming the content of each application, results will be announced on Friday, March 11, 2022, sent separately to each applicant's email address.

3. INFECTIOUS DISEASE PREVENTION MEASURES IN IN-PERSON CLASSROOMS

- ① Classroom Sanitation
- · An antibacterial coating will be applied to all surfaces in the classroom, including desks, chairs, walls, classroom equipment, etc.
- ② Droplet Prevention
- · Acrylic barriers have been set up in front of instructors' desks
- Instructors will wear masks during class.
- 3 Classroom Ventilation
- · Ventilation fans are always on in each classroom.
- · Both classroom doors and all windows will be kept open before the start of first period.
- In principle, doors and window will be kept open during classes, but on rainy or cold days, they will only be opened for 10 minutes every hour for ventilation. The windows will be opened after class finishes.
- · Large fans will be set up at the front and back of large classrooms.

- 4 Heath Management
- Thermometers have been set up in every building. If you are warned that you have a temperature of 37.5℃ or higher, please avoid contact with other people, and go to the Heath Clinic to measure your temperature again using a medical thermometer.

4. NOTES AND WARNINGS FOR THE START OF IN-PERSON CLASSES

- Students must wear masks on campus. (If you are not wearing a mask, you will not be allowed to attend class in the classroom. If you forget to bring a mask, please purchase one yourself from Lawson or the Co-op.)
- · Please avoid the Three Cs both on and off campus and wash your hands, sanitize, and gargle frequently.
- When using a computer provided by the university, please bring your own earphones/headphones. If you forget them, please purchase some from Lawson or the Co-op.
- · If you are feeling unwell, please consult with the Health Clinic straight away.
- Please refrain from speaking when eating in the cafeteria, etc. Please avoid off-campus group meals, parties, karaoke, and other activities that increase the risk of infection. When using public transportation to commute to campus, please wear a mask and refrain from talking on the bus or train.

5. **RECORDED CLASSES**

- Among the students who want to take classes on Zoom, those who want to take classes through recordings due to the time difference with Japan, poor internet connection, or other reasons that make it difficult to take classes in real time must apply in advance to take classes through recordings.
- The Dean of Academic Affair shall decide if students are allowed to take classes through recordings on the basis of their application.
- · Only courses that are determined to have sufficient academic merit even when taken through recordings shall be eligible.
- For more details, please check the website below. In addition, the current information is for the AY 2021 Fall Semester, so the details regarding the application method, etc. for the AY 2022 Spring Semester may change. (The website will be updated on February 28, 2022.)

Examinations implemented during the final exam period will be online. However, there may be some in-person examinations during the final exam period for Language Classes. For more details, please follow the instructions of your class instructor.
