Regulation No.777

#### Establishment

## Article 1

1. The University hereby establishes the Ritsumeikan Asia Pacific University Self-Assessment Committee ("the committee") to conduct self-assessments and publish its findings in order to improve the standard of education and research, achieve the University's basic ideals and fulfill its social mission

### Roles of the Committee

#### Article 2

- 1. The committee shall conduct a self-assessment of education, research, organizations, operations, facilities and equipment for each academic organization.
- 2. The committee shall handle the following items:
  - (1) Items concerning the formulation of basic policy and individual items for self-assessment.
  - (2) Items concerning self-assessment implementation, organizations and frameworks.
  - (3) Items concerning the summarization of self-assessment results for each academic organization.
  - (4) Items concerning the formulation of the Self-Assessment Report.
  - (5) Items concerning the disclosure of self-assessment results.
  - (6) Items concerning the handling of other self-assessment items, external evaluations and 3<sup>rd</sup>-party evaluations

# Committee Structure

### Article 3

- 1. The committee shall be established under the supervision of the President, and the heads of each organization shall be responsible for self-assessment.
- 2. The committee membership is as follows.
  - (1) Vice President
  - (2) Deans of the Colleges
  - (3) Deans of the Graduate Schools
  - (4) Dean of Academic Affairs
  - (5) Dean of Student Affairs
  - (6) Dean of International Cooperation & Research
  - (7) Dean of Admissions
  - (8) Dean of Careers

- (9) Director-General of UASS
- (10) Other members designated by the Chairman and act in his/her place in case of emergency or absence.
- 3. The Chairman and Vice Chairman will be designated by the President from among the committee members.
- 4. The Vice Chairman shall assist the Chairman and act in his/her place in case of emergency or absence.

## Reporting and Reflecting Results

### Article 4

- 1. The committee shall report results to the President and the Ritsumeikan Asia Pacific University University Evaluation Committee.
- 2. The President, upon receiving assessment results, shall reflect them in University plans.

# Committee Operation

## Article 5

- 1. The committee shall be convened at least once annually by the Chairman.
- 2. The Committee shall reach a quorum with at a simple majority of members in attendance.
- 3. Committee agenda items shall be approved by the members in attendance. The Chairman shall cast the deciding vote in the case of a tie.
- 4. In the case of the preceding paragraph, the Chairman may not be included in the committee members' resolution.

## Revision and Abolishment of Regulations

#### Article 6

 Revision or abolishment of these regulations shall be conducted by the President upon deliberations by the University Senate Meeting.

# **Supplementary Provisions**

These regulations shall go into effect on July 2nd, 2008, to be applied from April 1st, 2008.

These regulations shall go into effect on September 9th, 2014.
